NIT (3.a) Criteria of eligibility	NIT (3.a) Criteria of eligibility clause can be now read as “The tenderer should have completed satisfactorily at least *3 similar works each of value 40 % of the estimated cost or * 2 similar works of 50% of the estimated cost or * 1 similar work of 80 % value of the estimated cost during last 7 (seven) years.” (Works/Projects executed in Central govt./Central Autonomous bodies/Central PSU/State PSU/State Govt./Private Sector Companies both within and outside India will be considered).
4.	NIT (3.d) Criteria of eligibility	NIT (3.d) Criteria of eligibility Clause can be now read as “Joint venture is allowed but the Main bidder should have at least experience in execution of AMI(Advanced Metering Infrastructure)/SI (System Integration) in relevant areas (smart meters integration, SCADA integration with AMI or RAPDRP projects), and shall qualify all the eligibility criteria required as above. If the Main bidder sublets System Integration (SI) and Home Automation(HA) part, they shall submit work credentials for atleast two completed projects with cost in the field of SI and HA by the sublet party.
5.	Point to be added in NIT (Criteria of eligibility)	The Main bidder should satisfy all the Criteria of eligibility and points mentioned in the Tender documents, Corrigendum-1, 2 and 3.
